

VICTORIAN TAFE TRAINERS' 200 HOURS OF SUPERVISED PRACTICUM – EVIDENCE GUIDE

Schedule 4 of the *Victorian TAFE Teaching Staff Agreement 2018* specifies that an Australian Qualification Framework (AQF) level 5 teaching qualification must contain the following components to be considered eligible to be considered in employment grade applications:

- Studies in adult learning methodology
- Studies in teaching in a Vocational Education environment
- Studies in Applied Research (linked to the Boyer framework of scholarship), and
- 200 hours of supervised practicum.

To complete the Plenty Training 200 hours of supervised practicum RPL assessment workbook, you will need to be able to provide the following evidence.

IMPORTANT: Please be aware that the supervisor, qualified teacher, or trainer who has observed and evaluated you <u>MUST</u> hold one of the following:

- TAE50111 or TAE50116 Diploma of Vocational Education and Training,
- TAE50211 or TAE50216 Diploma of Training Design and Development, OR
- a higher qualification in education.

If you are in doubt, ask your supervisor/teacher/trainer for the name of the qualification he/she holds and contact your Course Advisor to assist you.
